Student Accountability Meeting (SAM) notification letter is sent to the student(s)
involved in the incident. The letter will include the date(s) in which a meeting will be held.

The interim suspension shall remain in effect until rescinded in writing or their case has reached a final resolution.

Student Accountability Meeting (SAM): A Student Accountability Meeting is a resolution convened to address alleged violations of the Code. During this meeting, the

Conduct Educators will determine the relevance of information and credibility of participants. The Office of Student Accountability & Academic Integrity may offer a SAM waiver, including proposed pathway projects,
